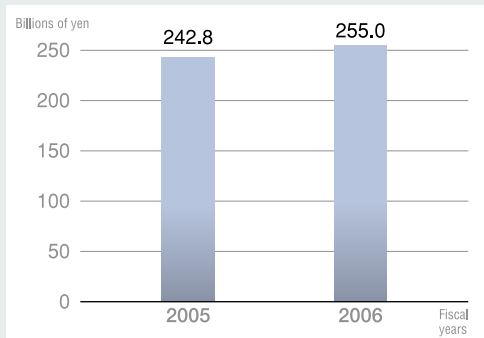




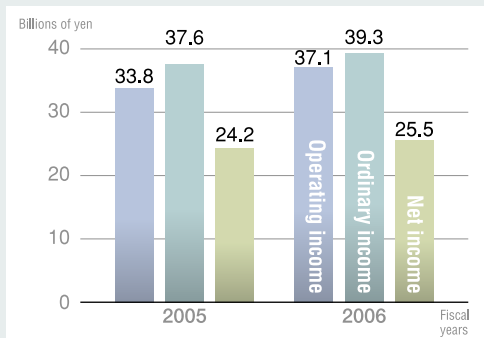

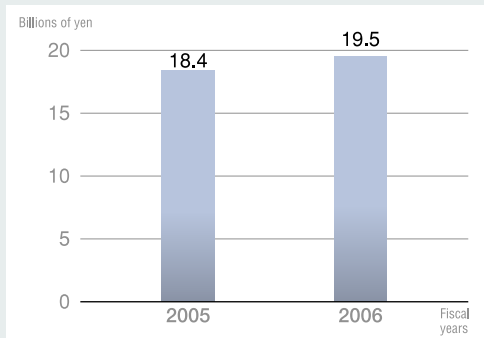
## ■ Net Sales (Non-consolidated)



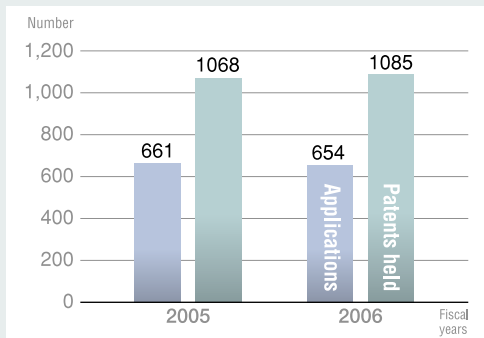
## ■ Operating Income, Ordinary Income and Net Income (Non-consolidated)
